## AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MEADOWVIEW HOMEOWNERS ASSOCIATION

THIS AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS FOR MEADOWVIEW HOMEOWNERS ASSOCIATION (hereafter "Amendment") is made and entered into as of 15 of April, 2010.

## WITNESSETH:

WHEREAS, there has arisen a need to allow owners in the community have temporary pools during the summer; and

WHEREAS, Section 14.2 authorizes amendment of the Declarations by the 2/3 of the Lot Owners; and

WHEREAS, 124 Lot Owners representing more than 2/3 of the Association have voted to Amend Article XI Section 11.3

NOW, THEREFORE, be it known as follows:

- 1. That two new paragraphs shall be added to Article XI Section 11.3 to read as follows;
- "11.3 <u>Temporary Pools</u>. Temporary pools shall be defined as "Pools of a temporary nature, deeper than 18", made from rubber, plastic or other materials other than Aluminum designed to be erected and taken down each summer."
- "11.4 Restrictions. Temporary pools shall be allowed, subject to approval from the architectural committee, with the following restrictions:
  - a) The Temporary Pool shall only be allowed to be erected from Memorial Day to Labor Day.
  - b) Temporary Pools shall only be allowed in the back yard area of any lot.
  - Lots with Temporary Pools shall be enclosed by a fence as allowed by these Declarations.

- d) Temporary Pools shall be in compliance with Jefferson County Codes and each Lot owner granted approval shall provide proof of compliance in order to keep the pool erected.
- Temporary Pools shall be stored out of sight during the off season.
- Temporary Pools shall subject to other sections of the Declarations. f)
